

My ICMP Bursary | 2023-24

Terms and Conditions

What is the My ICMP Bursary?

1. The My ICMP Bursary comprises a non-repayable award of £400 per semester to our UK domicile students.

The bursary is awarded automatically via Student Finance in two instalments of £400, paid in October 2023 and February 2024. There is no application process, and the scheme is open to all applicants who meet the criteria outlined in section 2.

Eligibility Criteria

- 2. Students will only be eligible for an award if they meet the following criteria:
 - a. A household income of less than £25,000.00, which will be evidenced via your application to the Student Loans Company.
 - b. A UK domicile undergraduate student.
 - c. Receiving Student Finance funding.
 - d. Students who have not applied for Student Finance due to religious reasons.
 - e. Enrolled on a full-time programme on campus at ICMP.

Excludes those:

- a. Studying via online or distance learning.
- b. Those retaking any year of their studies.

Application Process

3. There is no application process, the bursary is awarded automatically to all eligible students, as determined by Student Finance. Eligibility will be checked before payment is processed.

Payment Details

- 4. The bursary will be paid in two instalments of £400 in semester A and semester B by BACS (Bankers Automated Credit System) by Student Finance.
- 5. Students who have not applied for Student Finance due to religious reasons will be paid in two instalments of £400 in semester A and semester B by BACS (Bankers Automated Credit System) by ICMP.
- 6. The payment will only be paid if students have committed fully with the conditions of admittance, ICMP's regulations including meeting expected thresholds of attendance, engagement, and the student code of conduct.
- 7. It is the responsibility of the student to ensure that the bank details they provide to Student Finance or ICMP are correct. Incorrect bank details may cause delays in payment. If bank details have not been provided by the end of Semester B, the award for that year may be cancelled without further warning.
- 8. If you have overdue debt to ICMP, the bursary will be used as a debt relief to any outstanding debts.

- 9. All information supplied by the applicant as part of their application will be held and maintained in accordance with the provision of the General Data Protection Regulation (GDPR).

- 11. The bursary cannot be exchanged for an alternative award.
- 12. Receipt of this bursary does not affect eligibility for other bursaries or financial support offered by ICMP.
- 13. If the student's status changes during their study as a result of information not being provided, and the student becomes ineligible, ICMP reserves the right to revoke the bursary and claim back any payments incorrectly made to the recipient.
- 14. If a student breaks ICMP's regulations and is withdrawn from study, the bursary will be immediately terminated, and no further support will be available. Bursaries paid out will not be reclaimed.
